I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that a ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on November 24, 2009, upon a judgment rendered in Superior Court of SKAGIT County, Washington on November 12, 2009, in favor of CASCADE RIVER COMMUNITY CLUB, INC., A WASHINGTON NONPROFIT CORPORATION, for the sum of seven thousand twelve dollars and forty-nine cents (\$7,012.49).

The ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on December 11, 2009, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the ORDER OF SALE.
