The sale will be made without warranty, express or implied regarding title, possession, or encumbrances on 06/10/2011. 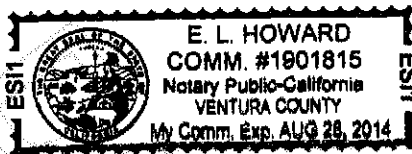
