## EXHIBIT "A" STATUTORY WARRANTY DEED

## Legal Description:

That portion of Block 3, Plat of Riverside Addition to the Town of Hamilton, recorded in Volume 2 of Plats, Page 83, records of Skagit County, Washington, being more particularly described as follows:

Commencing at the Northwest corner of said Block 3; thence South 88°07'23" East along the North line of said Block 3 a distance of 64.58 feet to the TRUE POINT OF BEGINNING; thence continue along said North line a distance of 287.31 feet to the Northeast corner of said Block 3; thence South 1°10'53" West along the East line of Said Block 3 a distance of 190.75 feet to the Southeast corner of said Block 3; thence North 88°07'23" West to the line of ordinary high water of the Skagit River; thence in a Northwesterly direction along the line of ordinary high water to a point which bears South 1°12'15" West from the true point of beginning; thence North 1°12'15" east to the TRUE POINT OF BEGINNING.
