Sign Easement Description

A 10.00 foot wide easement for signage, and the maintenance thereof, for the benefit of Lots 2 and 8, Western Peterbilt Binding Site Plan No. L-99-0003 recorded under Skagit County Auditor's File No. 200207010180 and re-plat of Lot 9, Western Peterbilt Binding Site Plan No. L-99-0003, City of Mount Vernon Binding Site Plan No. LU-07-036, recorded under Skagit County Auditor's File No. 200812080063, being in a portion of the Southwest 1/4 of the Northwest 1/4 of Section 32, Township 34 North, Range 4 East, W.M.; said 10.00 foot wide easement being more particularly described as follows:

BEGINNING at the Southeast corner of said Lot 2, Western Peterbilt Binding Site Plan No. L-99-0003;

thence South 89°32'54" West along the South line of said Lot 2, also being the Northerly right-of-way margin of Suzanne Lane, for a distance of 174.81 feet to a point of curvature;

thence along the arc of said curve to the right, concave to the Northeast, having a radius of 50.00 feet, through a central angle of 51°41'02" an arc distance of 45.10 feet, more or less, to a point that is 49.00 feet North (as measured perpendicular to and parallel with) of the centerline of Suzanne Lane the same is shown on the face of said Western Peterbilt Binding Site Plan No. L-99-0003, and being the TRUE POINT OF BEGINNING of said sign easement;

thence continue along the arc of said curve to the right, having a radius of 50.00 feet, through a central angle of 13°28'54" an arc distance of 11.77 feet, more or less, to a point that is 59.00 feet North (as measured perpendicular to and parallel with) of the centerline of said Suzanne Lane;

thence North 89°32'54" East parallel with said centerline of Suzanne Lane for a distance of 35.06 feet, more or less, to a point that is 70.00 feet East (as measured perpendicular to and parallel with) of the centerline of Old Highway 99 South, as the same is shown on the face of said Western Peterbilt Binding Site Plan No. L-99-0003;

thence South 0°24'33" West parallel with said centerline of Old Highway 99 South, for a distance of 10.00 feet, more or less, to a point bearing North 89°32'54" East from the TRUE POINT OF BEGINNING;

thence South 89°32'54" West for a distance of 28.76 feet, more or less, to the TRUE POINT OF BEGINNING.

SUBJECT TO and TOGETHER WITH easements, reservations, restrictions, covenants, liens, leases, court causes and other instruments of record.

Situate in the City of Mount Vernon, County of Skagit, State of Washington.

The above-described sign easement is intended to benefit the current lots mentioned above or any additional lots created through subsequent subdivisions of said lots.


