As of April 8, 2011, there is an outstanding balance of \$1,530.46 due and owing in connection with the following property at Skagit Highlands:



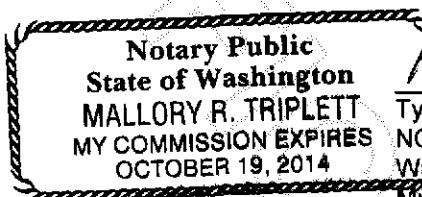
