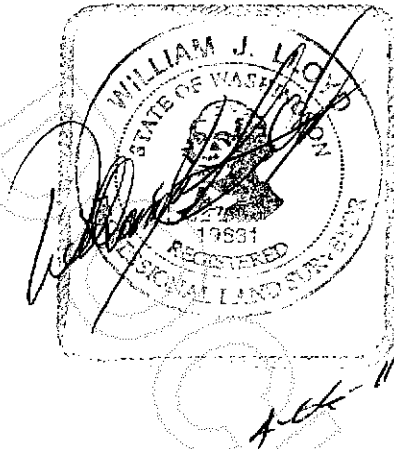

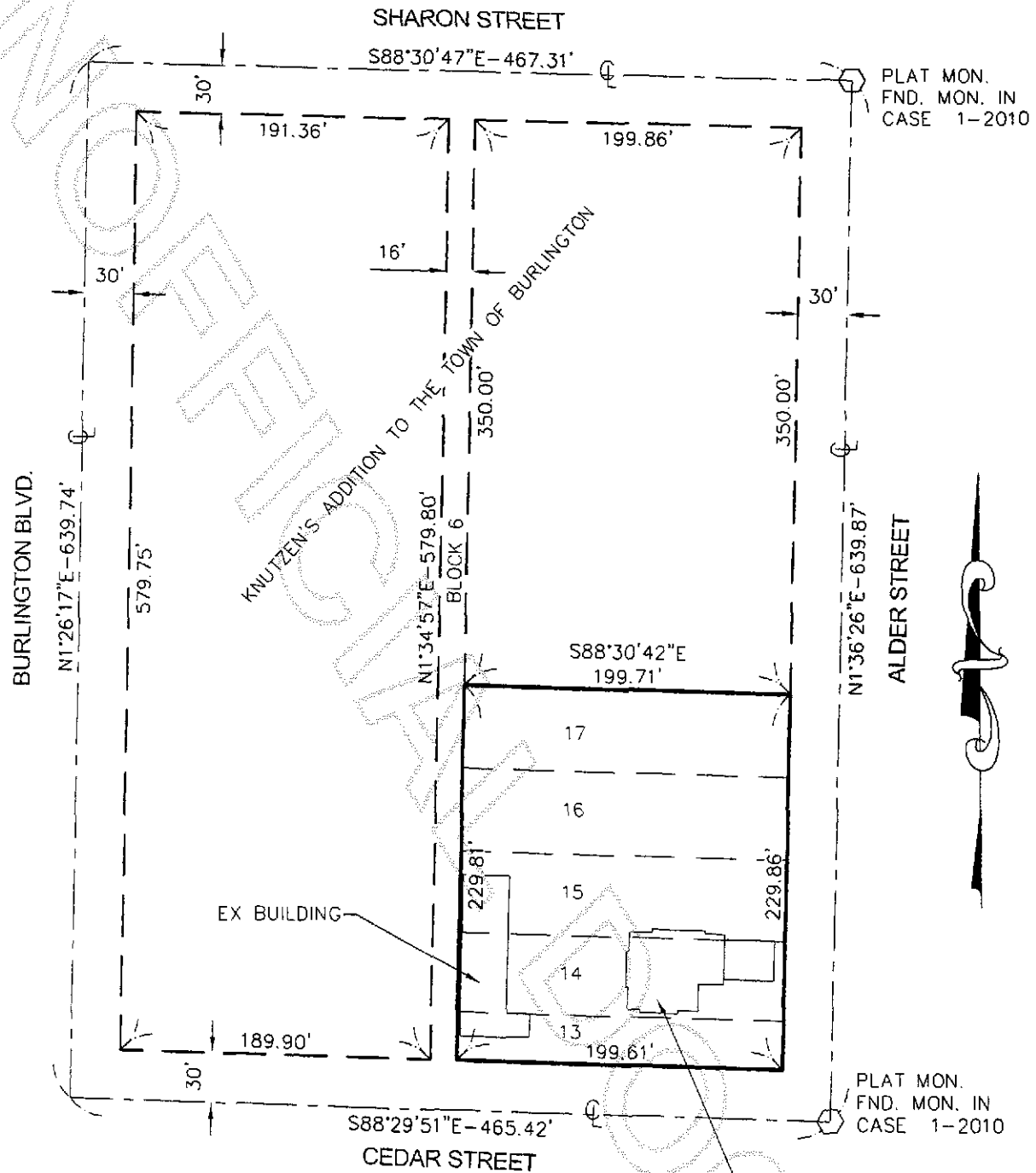

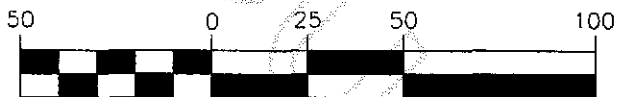


CEDAR STREET
