## EXHIBIT "A" STATUTORY WARRANTY DEED

## Legal Description:

That portion of the West ½ of Tract 13, "PLAT OF THE BURLINGTON ACREAGE PROPERTY," as per plat recorded in Volume 1 of Plats, page 49, records of Skagit County, Washington, described as follows:

thence continue South 89°46' West along said North line a distance of 33 feet; thence South 0°23'45" East parallel with the East line of said West ½ of Tract 13, a distance of 120.0 feet;

thence South 63°11'30" West 50.0 feet;

thence South 0°23'45" East 155.38 feet;

thence South 19°38' East 135.93 feet to the Northerly line of the State Highway;
