*The Northwest 1/4 of the Northwest 1/4, and Lot 6 of Section 36, Township 34 North, Range 2 East, W.M., containing 84.5 acres, more or less.
Situate in the County of Skagit, State of Washington.*

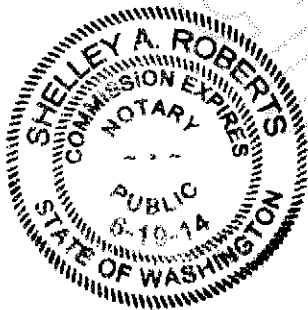
