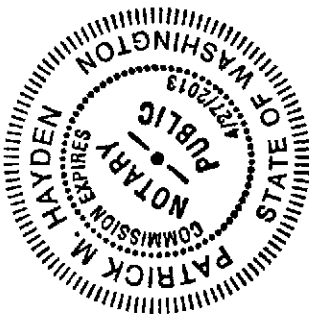

That portion of the Northeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ and of Government Lot 2 in Section 25, Township 34 North, Range 4 East, W.M., described as follows:
