<u>DURABLE</u> POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, ELAINE CATHELL, of St. Joseph, Missouri, have made, constituted and appointed, and by these presents do make, constitute and appoint, CANDEN E. CRIE, and in succession, CHRISTINE D. CHASTAIN, my true and lawful attorney for me, and in my name, place and stead to do and perform any and all of the following actions:

matters before all offices or officers of the Internal Revenue Service or the Treasury Department or the tax offices, officials or bureaus of any state, county or municipality, or of any other nation; to make, execute, verify and file all original and amended income tax returns, estate tax returns or gift tax returns and all other tax returns of any kind or character, to execute Form 2848 appointing a representative to act on the principal's behalf, to execute claims for refund, requests for extension of time, waivers and consents in my name; to execute petitions to the Tax Court of the United States and to cause me to be represented in such proceedings.

I hereby direct any and all banks, savings and loan associations, credit unions, safe deposit companies, corporations which are issuers or transfer agents of stocks, bonds or other securities, and/or any other firm, person or corporation which may have custody or control of any money, accounts, securities of any type, safe deposit boxes or the contents thereof, or other assets or property of any kind or description which I may own or to which I have right of access or in which I have any interest whatsoever, that any or all of such firms, persons or corporations shall and is hereby directed to grant access and/or control to my said attorney with respect to any of said items herein referred to; and that if such access or control shall be denied, any such firm, person or corporation responsible for such denial shall be as liable for any resulting damage as if I personally had been denied such access or control upon due demand made by me personally.

To make any and all arrangements deemed appropriate and in my best interests for my personal care, support, maintenance, living arrangements, medical, surgical or dental care; to authorize, consent, or request for me and in my name that I be admitted or placed as a patient or resident in any type of retirement home or facility, extended care facility, nursing care facility, hospital, or other similar facility; and to give consent for me and in my name to any and all types of medical treatment or procedures, dental treatment or procedures, or surgical procedures; to give consent for me and in my name, to waive the physician/patient privilege, and to the disclosure of any or all confidential or privileged information or communications in the possession of any person or institution and which may have been generated by the rendering of any care to me by any such person

or institution of any of the kind or types herein referred to; to sign, execute, acknowledge, and deliver for me and in my name any and all instruments or documents of any kind or type whatsoever deemed by my said attorney in the sole discretion of my said attorney to be in my best interests or to be necessary or appropriate in order to carry out any of the authority herein vested in my said attorney; to employ physicians, surgeons, dentists, nurses, paraprofessionals, or other individuals, to employ any institutions, to apply for and receive any benefits from any charitable or governmental agency or program and to change my residence, all as may be deemed necessary or appropriate by my said attorney in order to render to me any of the types of care herein referred to. This authority is specifically intended to grant full authority to my agents for access to all medical records and information under the Health Portability and Privacy Act (HIPPA).

So long as said CANDEN E. CRIE, and in succession, CHRISTINE D. CHASTAIN, are personally acting as attorney hereunder, said individual, as such attorney, is hereby authorized to fund any trust agreement I may have created with my assets.

Gifts. So long as said CANDEN E. CRIE, and in succession, CHRISTINE D. CHASTAIN, are personally acting as attorney hereunder, said individual, as such attorney, is hereby authorized to make gifts or transfers in my name out of my property and assets to such recipients (individuals or organizations) as in the sole discretion of said named individual as such attorney may deem appropriate and proper; whether for the purpose of estate planning and reduction or deferring of tax liabilities of myself or my estate or for such other purpose or purposes as may seem proper and appropriate to said individual as such attorney. Said individual, even though acting as attorney hereunder, may be a recipient of any such gift made pursuant to the power herein granted, provided, however, that any individual acting as attorney hereunder may only receive a gift whose fair market value qualifies for the annual exclusion as defined in Internal Revenue Code Section 2503(b) as amended.

Successor. The first named of said individuals is authorized to act alone if available; the first available one in order named of the others so named is authorized to act alone, but only if all previously named are unavailable.

Substitution. I hereby further authorize and empower my said attorney to substitute and appoint in the place and stead of my said attorney one or more attorney or attorneys to exercise for me as my attorney or attorneys any or all of the powers and authorities hereby conferred (except as otherwise specifically herein provided); and to revoke such appointment or appointments from time to time, and to substitute or appoint any other or others in the place of such attorney or attorneys as my said attorney herein named shall from time to time think fit.

Full Authority.
