1 maintenance and taxes on the property. There is now an offer for purchase of the property. The  
 2 Court approved the sale price at a hearing on July 22, 2011. Notice was sent to the Department of  
 3 Social and Health Services by first class regular mail on July 13, 2011.

4 4. It is in the best interest of the estate to sell the property at the price offered.

5 5. The Court having considered the affidavits by Gretchen Norby and Doug Owens finds  
 6 that there is clear and convincing intent of Charley R. Smith to convey the real property to Bruce  
 7 E. Norby by Quit Claim Deed dated November 15, 1983.

8 6. That Norby had knowledge and accepted the conveyance from Smith.

9 From the foregoing Findings of Fact, it is hereby

10 ORDERED, ADJUDGED AND DECREED that the Estate of Bruce E. Norby be vested

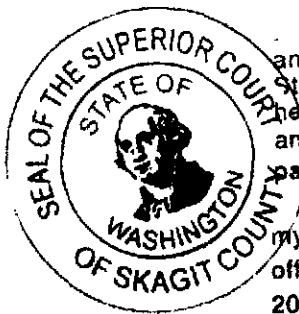
