maintenance and taxes on the property. There is now an offer for purchase of the property. The Court approved the sale price at a hearing on July 22,2011. Notice was sent to the Department of Social and Health Services by first class regular mail on July 13, 2011.

- 4. It is in the best interest of the estate to sell the property at the price offered.
- 5. The Court having considered the affidavits by Gretchen Norby and Doug Owens finds that there is clear and convincing intent of Charley R. Smith to convey the real property to Bruce E. Norby by Quit Claim Deed dated November 15, 1983.
  - 6. That Norby had knowledge and accepted the conveyance from Smith.
