- For and in consideration of a boundary line adjustment, and for no monetary consideration, Grantor does hereby declare the existence of a non-exclusive easement for ingress, egress and utilities over Parcel 1, benefitting Parcel 2, as depicted on the said Boundary Line Adjustment Survey, across under and through the real property described in the attached Exhibit A, and imposes the same as an appurtenance thereto.
- 2. Grantor does hereby further declare the existence of a non-exclusive easement for utilities over Parcel 2, benefitting Parcel 1, as depicted on the said Boundary Line Adjustment Survey, across under and through the real property described in the attached Exhibit B. and imposes the same as an appurtenance thereto.
- 3. The easements herein established shall be deemed effective upon the conveyance by Grantor, including a transfer by operation of law, of either Parcel 1 or Parcel 2 as herein described. It is the specific intention of the Grantor/Grantee that the easement(s) shall have no force and effect so long as both the dominant and servient estates are in common ownership, so as to avoid any question of merger.
