I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that an Order of Sale did issue out of the Superior Court of SKAGIT County, Washington, on August 24, 2010, upon a judgment rendered in Superior Court of SKAGIT County, Washington on July 21, 2010, in favor of U.S.Bank National Association ND, for the sum of three hundred fifty-two thousand, two hundred seventy-four dollars and thirty-six cents (\$352,274.36).

The Order of Sale, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on September 7, 2010, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the Order of Sale.

The Sheriff did, in obedience to the Order of Sale, levy upon the real property described below, and on November 5, 2010, sold the real property at public auction, for cash in hand, at the front door of the Skagit County Courthouse, 205 W. Kincaid, Mount Vernon, Skagit County, Washington, at 10:30 AM, after having first given notice of the time and place of the sale according to law.

At the sale, the premises were sold to CLAUS BROTHERS LLC ("Purchaser"), the highest and best bidder, for the sum of one hundred forty-four thousand and one dollar (\$144,001.00). The Sheriff thereupon delivered to said purchaser a Certificate of Sale as required by law and on December 3, 2010, the above entitled court in it's order made and duly entered, confirmed said sale.


