## **QUIT CLAIM DEED AND ASSIGNMENT**

SAMISH WATER DISTRICT (the "District"), pursuant to the provisions of that certain Memorandum of Agreement ("2011 MOA") executed between the District and UPPER SKAGIT INDIAN TRIBE (the "Tribe") to which this document is attached as Exhibit C, and in consideration of the sum of Fifty Thousand Dollars (\$50,000), hereby quit claims to the Tribe the District's right, title and interest, without warranty as to the condition or title, that certain sewer line running west from the east edge of the meter vault, which is depicted and described in the insert on page 2 of the Topographic Survey prepared by Pacific Survey and Engineering, which is attached to the 2011 MOA as Exhibit B (a copy of which is attached hereto). The section of sewer pipeline being conveyed to the Tribe is referred to in the 2011 MOA as the "West Pipeline", with the pipeline being retained by the District being referred to as the "East Pipeline". The District also conveys and assigns to the Tribe any existing easement rights, license or franchise rights, without warranty, that it may have to the West Pipeline, PROVIDED, However, the District expressly reserves, excepts and retains all easement rights it currently holds to access the retained portion of the District's sewer line (the "East Pipeline"), including the sewer lines running to the existing Thousand Trails Campground and the Washington State Department of Transportation Rest Stop; it being the intent of the parties that the District retain its existing access rights to the East Pipeline from North Dark Lane.


