

Portion of Lot 4 and 9, City of Anacortes Short Plat ANA06-011, recorded February 29, 2008, under Auditor's File No. 200802290164 and together with a portion of Lot 3 of Skagit County Short Plat 18-85, recorded September 9, 1985, under Auditor's File No. 198509090045, records of Skagit County Washington, Also, being a portion of the Northeast ¼ of the Southwest ¼ and Government Lot 3, Section 5, Township 34 North, Range 2 East, W.M. more particularly described as follows:

A 60-foot wide tract of land lying 30-feet on each side of the following described centerline.

Commencing at the center of Section 5, Township 34 North, Range 2 East, W.M., as shown on said Short Plat ANA06-011;

Thence: South 01° 37' 58" West, a distance of 597.84 feet, to the point of intersection of Old Brook Lane and Highway SR20;

Thence: North 87° 33' 28" West, a distance of 375.04 feet, along the centerline of said Old Brook Lane to the intersection of Old Brook Lane and South Fidalgo Bay Road, as identified under Auditor's File No. 200802290164;

Thence: North 01° 37' 57" East, a distance of 69.17 feet to a point of curvature;

Thence: Along a curve concave to the left, having a radius of 500 feet and central angle of 16° 04' 06", for a distance of 140.22 feet;

Thence: North 14° 26' 10" West, a distance of 362.77 feet to a point of curvature;

Thence: Along a curve concave to the left, having a radius of 180 feet and a central angle of 48° 57' 03", for a distance of 153.78 feet

Thence: North 63° 23' 13" West, a distance of 118.70 feet, to the TRUE POINT OF BEGINNING OF THIS DESCRIPTION;

Thence: Along a curve concave to the right, having a radius of 200 feet and a central angle of 97° 20' 06", for a distance of 339.76 feet;

Thence: North 33° 56' 53" West, a distance of 56.37 feet to a point of curvature;

Thence: Along a curve concave to the left, having a radius of 200 feet and a central angle of 32° 18' 55", for a distance of 172.80 feet, to a tangent point on the centerline of Scandia Court, as identified under Auditor's File No. 198509090045, which lies South 01° 37' 58" East and a distance of 191.18 feet from the South Line of South Fidalgo Bay Road Right-of-Way, as shown on said Short Plat 18-85, Auditor's File No. 198509090045, to the terminus of this description.
