- Association under Skagit County Recording No. 201106100037. Said Deed of Trust was modified on October 9, 2009 under Auditor's File No. 200910090068.
- Said Deed of Trust was executed to secure, together with other undertakings, the payments of a promissory note according to the terms thereof, in favor of Horizon Bank and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.
- The described Deed of Trust provides that the real property conveyed therein is 3. not used principally for agricultural or farming purposes.
- Default having occurred in the obligations secured and/or covenants of the 4.
