As of December 20, 2011, there is an outstanding balance of \$1,426.63 due and owing in connection with the following property at Skagit Highlands:



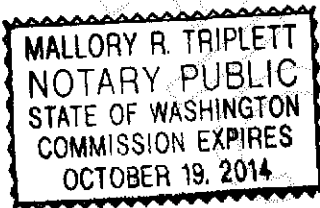
