That at the time of executing the Deed, Affiant believed and now believes that this consideration represents the fair value of the Property so deeded;

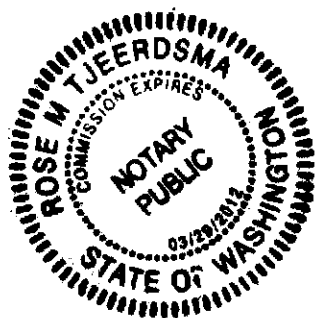
