## DEED TO REAL PROPERTY

THIS INDENTURE, made this 27th day of February, 2012 by and between the United States of America, Grantor, by Jill Pace, AI-Advisory Group Manager, Cal-Western on behalf of the Director, Advisory and Insolvency of the Internal Revenue Service, a duly authorized delegate of the Internal Revenue Service, Department of the Treasury, United States of America, 915 Second Avenue, M/S W245, Seattle, Washington 98174; and John Michael Hull, 801 Fidalgo Street, Sedro Woolley, WA 98284, Grantee.

## WITNESSETH

WHEREAS, the United States District Court for the Western District of Washington, in a Judgment entered on July 11, 2011, in the case of the United States of America v. Ralph Estill; Doylene Estill; Skagit County; State of Washington Employment Security Department; State of Washington Department of Labor and Industries; Bank of America; and American Building and Roofing, Inc, Civil Case No. 2:10-CV-773-JLR, ordered that the federal tax lien be foreclosed against the hereinafter described real property in order to pay delinquent Internal Revenue taxes assessed against Ralph J Estill and Doylene R Estill;
