**LEGAL DESCRIPTION**

That portion of the East  $\frac{1}{2}$  of Lot 15, Block 136, FIRST ADDITION TO BURLINGTON, SKAGIT CO., WASH., as per plat recorded in Volume 3 of Plats, page 11, records of Skagit County, Washington, described as follows:
