Appointment of Successor Trustee



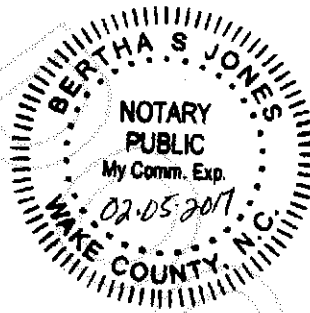
