The purpose of this deed is solely to correct an inaccuracy in the records of title.

This conveyance shall not and does not vacate, eliminate, modify, alter, or impair Grantor's (and public) use and/or possession of the public County right-of-way known as Matzdorf Street (County Road # 12100) located in the vicinity of property owned by Grantees.


