I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that an ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on May 16, 2011, upon a judgment rendered in Superior Court of SKAGIT County, Washington on April 20, 2011, in favor of CASCADE RIVER COMMUNITY CLUB, Inc., a Washington nonprofit corporation, for the sum of two thousand, two hundred sixty-five dollars and fifty-six cents (\$2,265.56).

The ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on May 18, 2011, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the ORDER OF SALE.

The Sheriff did, in obedience to the ORDER OF SALE, levy upon the real property described below, and on July 15, 2011, sold the real property at public auction, for cash in hand, at the front door of the Skagit County Courthouse, 205 W.
