Gordon and Carri Gordon, husband and wife, as Grantor, to Washington Services, Inc., a Washington Corporation as Trustee, and Washington Federal Savings as Beneficiary, dated February 8, 2007 recorded on March 5, 2007 as No. 200703050180.
