

4. Affiant has seen no evidence supporting that a bona fide standing contract exists between the Respondents and the THOMAS J. SWARTZ and or the ELIZABETH SWARTZ, where the THOMAS J. SWARTZ and or the ELIZABETH SWARTZ are liable to the Respondents for ANY OBLIGATION, and Affiant believes no such evidence exists.
5. Affiant has seen no evidence supporting that the THOMAS J. SWARTZ, has not requested and received a verified payoff statement from Skagit State Bank and Affiant believes no such evidence exists.
6. Affiant has seen no evidence supporting that the THOMAS J. 

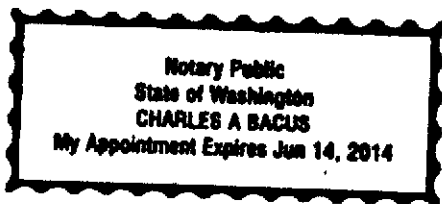

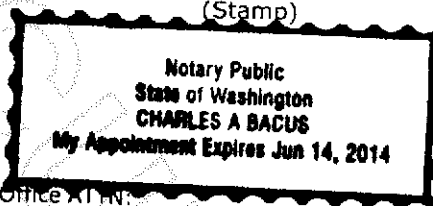
