JOANNE FRANCES CUSHMAN a/k/a JOANNE F. CUSHMAN, being first duly sworn on oath deposes and says:

- 1. NAME OF DECEDENT. That affiant is the surviving spouse of CECIL FRANK CUSHMAN a/k/a CECIL F. CUSHMAN, who died at Anacortes, Skagit County, Washington, on July 25, 2012. That at that time they were residents of Anacortes, Skagit County, Washington. That certified copy of Certificate of Death issued by the Washington State Department of Health is attached hereto, marked Exhibit "A" and by reference made a part hereof.
- 2. **EXECUTION OF AGREEMENT**. That on the 31st day of October, 1978, and while husband and wife, the affiant and the said CECIL FRANK CUSHMAN executed an agreement entitled "Community Property Agreement."
