SUBORDINATION AGREEMENT

The undersigned subordinator and owner agree as follows:

- 2. JP Morgan Chase Bank, NA referred to herein as "lender," is the owner and holder of a mortgage dated <u>09/07/2012</u> executed by Ronald A. Kennedy and Catherine M. Kennedy which is recorded under auditor's file No. <u>2012/09/10/32</u>, records of Skagit County) (which is to be recorded concurrently herewith).
