A 50 foot wide strip of land 25 feet on each side of a below described centerline over that portion of Lot 3 of Boundary Line Adjustment Survey recorded July 17, 2007, under Auditor's File No. 200707170052, records of Skagit County, Washington; being a portion of the Southeast ¼ and Government Lot 3 of Section 27, Township 35 North, Range 1 East, W.M., and a portion of Lots 69 through 71, "ANACO BEACH, SKAGIT COUNTY, WASHINGTON," as per plat recorded in Volume 5 of Plats, page 4, records of Skagit County, Washington, described as follows:

Commencing at the point of intersection of the most Southerly line of said Lot 3 and the Easterly margin of Marine Drive and the beginning of a non-tangent curve concave to the South having a radius of 180.00 feet and to which point a radial line bears South 89°07'44" West;

thence Northerly and Northwesterly 152.33 feet along said curve through a central angle of 48°29'17" to the point of beginning of said centerline;

thence North 43°48'21" East 29.66 feet to the beginning of a curve to the right having a radius of 60.00 feet:

thence Northeasterly 21.94 feet along said curve through a central angle of 20°56'56";

thence North 64°45'17" East 41.87 feet to the beginning of a curve to the left having a radius of 100.00 feet:

thence 63.76 feet Northeasterly along said curve through a central angle of 36°31'58" to the Northeasterly boundary of said Lot 3, extending and truncating as necessary.
