## ASSIGNMENT OF DEED OF TRUST AND OTHER COLLATERAL DOCUMENTS

Assignor is the legal and equitable owner and holder of that certain Fixed/Adjustable Rate Note in the original principal amount of \$169,875 dated February 28, 2007 (the "Note"), which Note is secured by, among other things, that certain Deed of Trust executed by Gerald D. Fischer and Karane Fischer, Husband and Wife (collectively, "Borrower"), as Borrower, to Cascade Bank, as Lender, for the benefit of Assignor, dated February 28, 2007, and recorded on March 5, 2007, as Instrument No. 200703050170 in the Office of the Skagit County Auditor, Washington (the "Deed of Trust") regarding the real property as more particularly described on Schedule 1 attached hereto and incorporated by this reference.
- B. Assignor has simultaneously herewith executed an allonge to the Note, effectively endorsing the Note to Assignee, and the parties desire that the Deed of Trust and all other documents executed in connection with the loan be assigned to Assignee.

THIS ASSIGNMENT IS MADE WITHOUT RECOURSE OR WARRANTY OF ANY KIND, AND ASSIGNOR MAKES NO REPRESENTATIONS OR WARRANTY, EXPRESS OR IMPLIED, OF ANY KIND OR NATURE WHATSOEVER WITH RESPECT TO THE NOTE, THE OBLIGATIONS EVIDENCED BY THE NOTE, THE RELATED DOCUMENTS OR THE COLLATERAL, IF ANY, EXCEPT AS EXPRESSLY PROVIDED UNDER THAT CERTAIN LOAN PURCHASE AGREEMENT AND JOINT ESCROW INSTRUCTIONS DATED September 14, 2012 BETWEEN ASSIGNOR AND ASSIGNEE (THE "LOAN PURCHASE AGREEMENT").
- 4. This Assignment shall be governed by and construed in accordance with the laws of the State of California.
