

Fischer and Karane Fischer, Husband and Wife (collectively, "Borrower"), as Borrower, to Cascade Bank, as Lender, for the benefit of Assignor, dated February 28, 2007, and recorded on March 5, 2007, as Instrument No. 200703050166 in the Office of the Skagit County Auditor, Washington (the "Deed of Trust") regarding the real property as more particularly described on Schedule 1 attached hereto and incorporated by this reference.

THIS ASSIGNMENT IS MADE WITHOUT RECOURSE OR WARRANTY OF ANY KIND, AND ASSIGNOR MAKES NO REPRESENTATIONS OR WARRANTY, EXPRESS OR IMPLIED, OF ANY KIND OR NATURE WHATSOEVER WITH RESPECT TO THE NOTE, THE OBLIGATIONS EVIDENCED BY THE NOTE, THE RELATED DOCUMENTS OR THE COLLATERAL, IF ANY, EXCEPT AS EXPRESSLY PROVIDED UNDER THAT CERTAIN LOAN PURCHASE AGREEMENT AND JOINT ESCROW INSTRUCTIONS DATED September 14, 2012 BETWEEN ASSIGNOR AND ASSIGNEE (THE "LOAN PURCHASE AGREEMENT").
- 4. This Assignment shall be governed by and construed in accordance with the laws of the State of California.
