ASSIGNMENT OF SEWER LIFT STATION/UTILITY CORRIDOR EASEMENT

THIS ASSIGNMENT OF SEWER LIFT STATION/UTILITY CORRIDOR EASEMENT ("Assignment") is made this 5th day of October, 2012, by the **PORT OF ANACORTES** ("Port" or "Assignor") and the **CITY OF ANACORTES** ("City" or "Assignee").

WHEREAS, the Port is the grantee under the Sewer Lift Station/Utility Corridor and Esplanade Easement recorded under Skagit County Auditor File No. 200906190002 (the "Easement") and as such is the holder of certain rights and/or obligations granted in the Easement;

WHEREAS, the Easement authorizes the Port to assign its rights and/or obligations arising and granted thereunder to the City;

WHEREAS, the Port desires to assign certain rights and/or obligations arising out of and granted under the Easement to the City; and


WHEREAS, the City desires to accept certain of the Port's rights and/or obligations arising out of and granted under the Easement.

NOW, THEREFORE, the Port does hereby assign to the City, and the City does hereby accept from the Port, the benefits and rights, together with and subject to all duties and obligations, of the Grantee set forth in the Easement. Notwithstanding the foregoing, the Port expressly retains: i) all benefits and rights granted to it as an owner of Lot 3, as further described and set forth in the Easement, and ii) all benefits and rights granted to it in relation to the additional Esplanade easement, as further described and set forth in the Easement.






