SETTLEMENT AND RELEASE OF INTEREST MAGNO DISSOLUTION, SKAGIT COUNTY SUPERIOR COURT No. 11-3-00630-8

The undersigned, Louise Magno and Anthony Magno, do hereby declare:

1. Louise Magno is the petitioner in Skagit County Superior Court no. 11-

3-00630-8 and former wife of Anthony Magno, respondent.

2. Pursuant to Exhibit A, section V "Real Property Division" of our Decree

of Dissolution, entered December 23, 2011, we have exercised reasonable efforts to

list and sell the family home and real property at 14307 Roadrunner Lane,

Burlington, Washington, Skagit county tax parcel number 4876-000-022-0000. We

have fully complied with the Decree in this regard, have listed the property and

adjusted the list price, and have paid the indebtedness, maintenance, taxes as

required by our Decree. The house has not sold despite these efforts. The balance

owed on the purchase indebtedness now exceeds the likely sale price of the

property. There is no equity in the property. We both agree that further effort to sell

the property is not feasible or desirable.

3. I, Louise Magno, do hereby agree to release my interest in the property

by quit claim deed to my former husband, Anthony Magno, in exchange for his

assumption of the remaining debt and refinance of the property to remove me from

the current loan. I waive all further right and interest in possession, occupancy,

rents, profits, proceeds and interest in the property. I also waive the provisions of our Decree for review, adjustment, arbitration and all other remedies under the law of Washington for modification or enforcement of our Decree relating to this property.

- 4. I, Anthony Magno, do hereby agree to refinance the existing loan and indebtedness upon the home and real property to release Louise Magno from all further liability on said indebtedness, in consideration of the release of interest of all interest in said property by my former wife, Louise Magno, to me.
- 5. We agree and intend that this settlement and release of interest is a modification of the terms of our property settlement expressed in our Decree of Dissolution and that the Quit Claim Deed given by Louise Magno as grantor to Anthony Magno as grantee of even date is for the purpose of division of property incident to our divorce.
