SUBORDINATION AGREEMENT

- 1. Peoples Bank, A Washington Corporation referred to herein as "subordinator", is the owner and holder of a <u>Deed of Trust</u> dated <u>June 19, 2006</u> which was recorded on <u>June 21, 2006</u> under auditors file No 200606210045 records of Skagit County, Washington.
- 2. MERS as nominee for Peoples Bank referred to herein as "lender", is the owner and holder of a Deed of Trust dated December 27, 2012 , executed by Emanuel Vena and Ann Tweedy, husband and wife, which is recorded under auditor's file No. 2013 01040043 records of Skagit County, Washington (which is to be recorded concurrently herewith).
- 3. Emanuel Vena and Ann Tweedy, husband and wife, referred to herein as "owner", is the owner of all real property described in the mortgage identified above in paragraph 2.
