The West 1/2 of Government Lot 3, Section 1, Township 33 North, Range 3 East, W.M.; EXCEPT the West ten (10) acres thereof; and EXCEPT the County Road right of way along the North line thereof.

TOGETHER WITH AND SUBJECT TO a reciprocal easement benefiting and burdening both the Grantors and Grantee over, across, and through Parcel A conveyed as described above, Parcel D, representing tax parcel P15237, lot certification PL00-0814, Parcel E, which is lot certification PL00-0808, for ingress and egress of farm vehicles and implements to access the farmlands owned and/or leased by the Grantors currently designated by the Skagit County Assessor as tax parcels P15273, P15274, P15237, and P15238.


