

 12 defendant(s), being duly advised in the premises, NOW, THEREFORE, it is hereby


13 IT IS ORDERED that Plaintiff's motion for Summary Judgment is hereby granted and

 17 Judgment is for a total amount of \$11,513.45.


18 IT IS FURTHER ORDERED that Plaintiff and its agents, attorneys and assigns are
