As of March 15, 2013, there is an outstanding balance of \$1,325.50 due and owing in connection with the following property at Skagit Highlands:



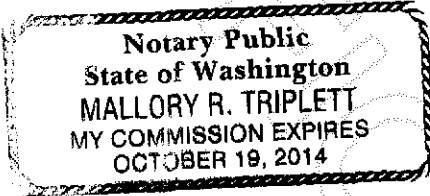
