- This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between Thomas Lee Robinson, A Single Man, as Grantor, to Land Title Company of Skagit County as Trustee, and Mortgage Electronic Registration Systems, Inc. is a separate corporation that is acting solely as a nominee for Banner Bank and its successors and assigns as Beneficiary, dated October 22, 2007 recorded on October 26, 2007 as No. 200710260138.
- 2. Said Deed of Trust was executed to secure, together with other undertakings, the payments of a promissory note according to the terms thereof, in favor of Banner Bank and its successors and assigns and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.
