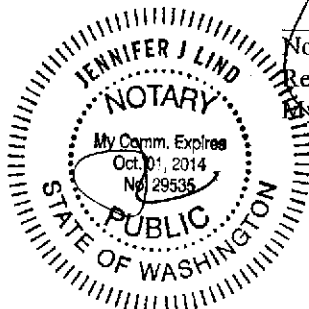

thence West 21 and $\frac{6}{7}$ ths rods;

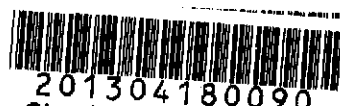
