IX.



NOTICE TO OCCUPANTS OR TENANTS

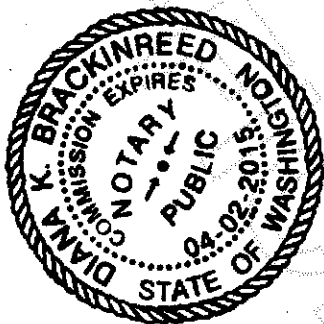
