ORDER AND FINAL JUDGMENT

This matter came before this Court on the Plaintiff's Motion for Judgment by Default. The Court reviewed the records and files herein including, but not limited to, the Complaint and the Motion and supporting Declaration with exhibits. The Court entered an Order of Default, and has concluded that the relief requested herein does not exceed the relief sought in the Complaint, Plaintiff has made a sufficient showing for entry of a final judgment, and the Motion is otherwise well taken. Now, therefore, it is hereby

ORDERED as follows:

1. The Deed in Lieu of Foreclosure granted by Homestar Northwest, LLC to Mariner's Ridge Investment Group dated November 18, 2011 and recorded on September 1, 2011 under Skagit County Auditor's Number 201109010017, was a fraudulent conveyance pursuant to Section 548 of the United States Bankruptcy Code. The Deed in Lieu of Foreclosure is hereby avoided. The real property transferred consisted of five parcels with the following parcel numbers:

P124675-4894-001-000-0000 ("P000") P124677-4894-000-999-0000 ("P999") P127644-4959-002-200-0000 ("P200") P127646-4959-002-202-0000 ("P202") P127467-4959-002-203-0000 ("P203")

2. The transfer of the real estate described in the Deed in Lieu of Foreclosure to Defendant, by Quit Claim Deed recorded with the Skagit County Auditor on November 28, 2011, Auditors number 201111280113, was for no consideration. The Trustee is

therefore entitled to recover from the Defendant all of the Debtor's interest in the five parcels listed above.

- 3. Because parcel numbers P127644-4959-002-200-0000 ("P200") and P127646-4959-002-202-0000 ("P202") were sold by Defendant to bona fide purchasers, the Trustee is entitled to recover the value of the property transferred with respect to P200 and P202. The Trustee is therefore awarded a money judgment against the Defendant for the principal amount of \$176,246.10, plus costs of suit in the form of the \$293.00 filing fee.
- 4. Nothing in this Order and Final Judgment cuts off the rights any individual investors may have under Washington law to argue that they have some type of equitable lien or mortgage in the property at issue in this proceeding.
