LEGAL DESCRIPTION

That portion of the Southeast 1/4 of Section 8, Township 35 North, Range 6 East, W.M., lying Easterly of the CCC Road and described as follows:

Beginning at the Southeast corner of said Section 8;

thence North 01°43'40" West along the East line of said Section 8, a distance of 1,387.51 feet to the point of beginning of this description;

thence North 87°58'08" West, a distance of 1,635.60 feet to the Easterly right of way line of the County Road (Pipeline Road - CCC Road);

thence North 10°27'10" East along said right of way, a distance of 386.89 feet;

thence continuing along said right of way North 20°08'25" East, a distance of 194.31 feet;

thence continuing along said right of way North 36°47'48" East, a distance of 11.84 feet;

thence South 86°58'08" East, a distance of 1,475.82 feet to the East line of said Section 8;

thence South 01°43'40" East along said East line, a distance of 552,57 feet to the point of beginning.
