GRANT OF EASEMENT

For valuable consideration in hand paid, The Grantor, PORT OF ANACORTES, a municipal corporation, grants to the Grantee, CITY OF ANACORTES, a municipal corporation, a permanent easement, subject to the terms and conditions herein:

- (1) to construct, lay, install, inspect, monitor, maintain, repair, renew, substitute, replace, remove, operate, and use an eight-inch (8") diameter underground water pipeline under and through the below-described real property ("the Easement Area"), together with the right of ingress and egress over said property for the purposes for which the above-mentioned rights are granted; and
- (2) to allow Anacortes Yacht Club and its agents to construct a gravel driveway approximately eight (8) feet in width over the entire length of the Easement Area, which, upon completion of construction, shall become the sole property of Grantor, subject to the terms and conditions of this Easement Declaration, and for which Grantee shall have no maintenance or other responsibility whatsoever.

The Easement Area is legally described as follows:

The East 20.00 feet of the following described parcel:

Lots 6 to 10 inclusive, Block 21, BOWMAN'S CENTRAL SHIP HARBOR WATER FRONT PLAT OF ANACORTES, SKAGIT COUNTY, WASHINGTON, according to the plat thereof recorded in Volume 2 of Plats, page 33, lying Northerly of the meander line or line of ordinary high tide, whichever is farthest out;

EXCEPT that portion of a 60 foot wide strip deeded to the City of Anacortes by deed dated July 1, 1924 and recorded September 4, 1924 under Auditor's File No. 176938, records of Skagit County, Washington.

Situated in Skagit County, Washington.

Grantor covenants and agrees:

- 1. To refrain from causing the construction or placement of any structure or building, street light, power pole, or yard light within any part of the Easement Area without the advance written consent of Grantee.
- 2. That Grantee shall have the right to remove any plants within the Easement Area as necessary or appropriate to construct the above-described driveway and install and undertake operations, maintenance and/or replacement of its facilities without the obligation to replace such plants or any other liability therefor.
- 3. That Grantor shall not take nor permit any action that impairs the lateral or subjacent support for the water pipeline or adds or removes more than 12" to or from the earth cover over the pipeline, without advance, written authorization from Grantee.
- 4. Public utilities other than the eight-inch waterline described above, such as additional or greater diameter water lines, storm sewer, gas, electric, telephone, data transmission, communication, and cable television lines may be installed in the Easement Area only with the written authorization of both Grantor and Grantee, and on the condition that they do not interfere with the Grantee's rights herein expressed.
- 5. Grantor retains the right to the undisturbed use and occupancy of the Property insofar as such use and occupancy is consistent with and does not impair any grant or covenant contained in this Agreement.
