## SUBORDINATION AGREEMENT

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- SOUND CREDIT UNION fka WATERMARK CREDIT UNION referred to herein as "subordinator," is the owner and holder of a mortgage, dated June 22, 2010, which is recorded in volume \_\_\_\_\_ of Mortgages, page \_\_\_\_\_ under auditor's file No. 201006280077, records of Skagit County.
- 2. WELLS FARGO BANK, N.A. referred to herein as "lender," is the owner and holder of a mortgage dated 7313 for no more than \$103,500.00, executed by Gary VanAusdle and Nancy VanAusdle (which is recorded in volume of Mortgages, page under auditor's file No201307090100, records of Skagit County) (which is to be recorded concurrently herewith).
- 3. Gary VanAusdle and Nancy VanAusdle referred to herein as "owner," is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4.
