EASEMENT

This document replaces document number 200808210001 of Skagit County.

Herbert M. Wiseman and Nancy J. Wiseman, husband and wife, grantors herein, hereby grant to the McMurray Cemetery Association, a perpetual easement - in part of Parcel # P127067 located in part of the NE ¼ of Section 36, Township 33 North, Range 4 East, W.M. - for ingress and egress over an existing 4-foot-wide gravel foot path lying 2 feet on each side of the following described line:

Beginning on the as-built centerline of State Highway 9 at the most northerly corner of Lot 2, Skagit County Short Plat No. PL04-0757, recorded January 15, 2008 under Auditor's File No. 200801150090, records of Skagit County, Washington;

Thence S33°44'42"W along the northwesterly boundary of said Lot 2 a distance of 30.91 feet to the True Point of Beginning;

Thence S52°36'58"E a distance of 22.47; thence S48°51'38"E feet a distance of 22.87 feet; thence S46°17'54"E a distance of 14.40 feet; thence S43°31'23"E a distance of 15.58 feet; thence S37°06'18"E a distance of 14.88 feet; thence S25°59'00"E a distance of 13.13 feet; thence S31°28'10"E a distance of 14.53 feet; thence S35°52'07"E a distance of 13.91 feet; thence S38°51'56"E a distance of 14.28 feet; thence S43°38'26"E a distance of 10.65 feet to a point on the easterly boundary of said Lot 2 that is S49°59'40"W a distance of 54.22 feet from a point on the as-built centerline of State Highway 9 at the most northeasterly corner of said Lot 2 and the end of this easement.
