INTRODUCTION: I, MARIE F. JACOBSON, do hereby state that I am now a resident of Skagit County, Washington, and do hereby make, publish and declare this instrument to be my Last Will and Testament.

FIRST: <u>Family</u>. I am not now married. I have one child now living, <u>namely</u>: DAVID L. JACOBSON. Each reference in this Will to "my child" or "child of mine" is a reference to my child named in this paragraph.

SECOND: Funeral and burial. I direct that my funeral services be conducted in a manner and that I be buried at a location suitable to the wishes of my immediate family.

THIRD: Personal representative. I nominate as personal representative of this Will: first, my son, DAVID L. JACOBSON; and second, my sister, LUCILLE C. BROTHERS. Each shall serve as sole personal representative without bond and the priority of appointment and their order of succession, if one for any reason fails to qualify or ceases to act as such personal representative, shall be in the order in which they are named above.

FOURTH: Payment of expenses and debts. I direct my personal representative to pay from the residue of my estate as soon as practicable after my death the expenses of my last illness, the expenses of my funeral and burial, my just debts, all inheritance and estate taxes imposed on my taxable estate including life insurance or any beneficiary thereof, and the expense of admin-istrating my estate.

FIFTH: Gift of residue of my estate. I give, bequeath and devise all of the rest and residue and remainder of my estate of whatever nature and wherever situated as follows:

1. If my child, DAVID L. JACOBSON, survives me, then I give the residue of my estate to my child; or if my child, DAVID L. JACOBSON, predeceases me leaving issue surviving me, then I give the residue of my estate to the issue, per stirpes, of my deceased child, DAVID L. JACOBSON.

2. If my child, DAVID L. JACOBSON, and all of his issue predecease me, then I give the residue of my estate of my sister, LUCILLE C. BROTHERS.

3. If my child, DAVID L. JACOBSON, all of his issue, and my sister, LUCILLE C. BROTHERS, all predecease me, then I give the residue of my estate to my heirs. The identities and the respective shares of my heirs shall be determined at the date of my death and according to the laws of the state of Washington then in effect relating to the succession of separate property not acquired from a predeceased spouse.

I further direct that my estate be settled without the intervention of any court, except to the extent required by law, and that my executor or executrix settle my estate in such a manner as shall seem best and most convenient to her or to him, and I hereby empower my executor or executrix to mortgage, lease, sell, exchange and convey the real and personal property of my estate without an order of court for that purpose and without notice, approval or confirmation, and in all other respects to administer and settle my estate without the intervention of the court.
