### SUBORDINATION AGREEMENT

**FROM** SKAGIT STATE BANK, with its primary office address at 1575 S BURLINGTON BLVD, BURLINGTON, WA 98233 (hereinafter called "Beneficiary")

**TO** JP MORGAN CHASE BANK, NA, with its primary office address at 100 WEST UNIVERSITY DRIVE F5, TEMPE, AZ 85281 (hereinafter called "Lender")

Whereas, Beneficiary is the holder of a valid Deed of Trust granted to MICHAEL L. CHERRY AND KATHRYN M. CHERRY, HUSBAND AND WIFE (hereinafter called "Owner") covering certain real property owned by Owner and located at 24094 WALKER VALLEY RD MOUNT VERNON WA 98274, more fully described on Exhibit "A" hereto and incorporated herein (hereinafter called "Property") which Deed of Trust secured a note dated 06/08/2009 in favor of SKAGIT STATE BANK in the original principal sum of \$27,000.00 which recorded on 06/11/2009 in the SKAGIT County Recorder's Office, at INST # 200906110066, (hereinafter the "prior Deed of Trust"); and

WHEREAS, Owner has executed, or is about to execute a Deed of Trust (hereinafter referred to as "Lender's Security Instrument") and note not to exceed the sum of \$155,965.00, dated , in favor of Lender, payable with interest and upon the terms and conditions described therein, which Lender's Security Instrument is to be recorded concurrently herewith; and

Whereas, the BENEFICIARY has agreed to subordinate the PRIOR DEED OF TRUST to LENDER'S DEED OF TRUST.

NOW, THEREFORE, INTENDING TO BE LEGALLY BOUND and in consideration of \$1.00

1. Subordination of Lien: The BENEFICIARY hereby subordinates the PRIOR DEED OF TRUST and its lien position in and on the PROPERTY to the LENDER'S Deed of Trust and the lien thereof, as if the LENDER'S Deed of Trust has been recorded first in time to the PRIOR DEED OF TRUST and so that all public records will reflect LENDER'S Deed of Trust superior in lien to the PRIOR DEED OF TRUST.

2. This subordination shall be binding upon and insure to the benefit of the respective heirs, successors and assigns of DEED OF TRUST and LENDER.


