THIS AGREEMENT dated the day of August 2013 is between the Port of Skagit County, a Washington municipal corporation, the "Lessor," and Gubrud Family Properties, LLC a Washington limited liability company, the "Lessee."

I. RECITALS

WHEREAS, Lessor leased certain premises, hereinafter referred to as "the Premises," to Lessee pursuant to an Assignment of Lease Agreement by Successive Assignments, dated July 12, 2007, recorded under Skagit County Auditor's No. 200707170073, wherein Lessee assumed all of the former Lessee's obligations contained in the Lease Agreement dated October 15, 1999, recorded under Skagit County Auditor's No. 199910150098, hereinafter referred to as "Lease," which is incorporated herein as though fully set forth here; and

WHEREAS, Lessor has agreed to purchase Lessee's buildings and all of Lessee's improvements on the Premises and the parties have therefore agreed to terminate the Lease at closing of the sale of Lessee's building and improvements to Lessor; and

II. AGREEMENT

NOW THEREFORE in consideration of the mutuality of benefits to be derived herefrom, the parties agree that the Lease is terminated as of the date and time of the last signature to appear hereon by a party hereto; *provided*, that those provisions thereof that would provide remedies to the parties for undiscovered claims at the time hereof shall survive to the extent otherwise permitted by law;
