As of August 22, 2013, there is an outstanding balance of \$2,840.00 due and owing in connection with the following property at Skagit Highlands:



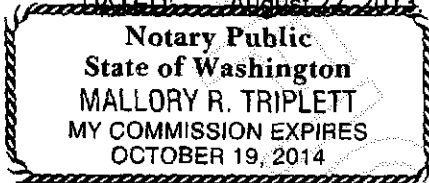
