A sale of the corporation, limited liability company or partnership interest greater than 49% of the voting stock, partnership interests, or member interests through issuance of additional shares or interests shall likewise constitutes a "transfer". In the case of a conveyance or contract to convey, the interest shall likewise increase to the default amount or the holder may consent to the conveyance or contract to convey and increase the interest rate provided for herein.
